

REGULATIONS

Selected artist

DURATION AND FORMAT OF THE SONG/PERFORMANCE/STAGE/CLOTHING:

- The song used must be sent to the organization via email as an .mp3 file, no later than the registration deadline (March 15th). Songs sent after the registration deadline will not be accepted. It is up to the performer to check the quality of the song and the length of the song, already cut.
- Duration of the performance: from a minimum of 2.30 minutes to a maximum of 3.30 minutes
- There are no mandatory or forbidden figures in any of the two main categories and the Amateur and Expert levels.
- Being a show as well as a contest, great importance will be given to the overall performance, originality and artistry of the above, as well as the technique in execution of the figures.
- On the stage there will be a single permanent pole, floor to ceiling, not freestanding.
- Choose whether to use it on static or spin mode.
- All types of grips can be used.
- Any type of costume or footwear is allowed. You can use props or scenographies as long as they are transportable by the performer herself or by an accompanying person.
- If during the performance you'll dirty the stage, it must be indicated on the registration form.
- No nudity is allowed.

For those who bring on stage one or more additional partners, they will have to communicate it to the organization and there will be a fee of € 15 for each person. All this must be attached to the registration email. Even the people who will participate with the competing athlete will have to register with CSI. Minimum age for participation is 16 Years; minors must be authorized by the parents.

The best performers will be rewarded as follows:

- 1st, 2nd, 3rd place Amateur
- 1st, 2nd, 3rd Expert
- 1st Contest's Absolute Winner.
